The bond ordinance, the summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of the City of Orange Township, in the County of Essex, State of New Jersey, on November 14, 2016. It will be further considered for final passage, after public hearing thereon, at a meeting of the governing body to be held at the City Hall in said City on December 6, 2016 at 7:00 p.m. During the week prior to and up to and including the date of such meeting, copies of the full ordinance will be available at no cost and during regular business hours at the Clerk's office for the members of the general public who shall request the same. The summary of the terms of such bond ordinance follows:

<b>Title:</b>	<b>BOND ORDINANCE PROVIDING FOR IMPROVEMENTS TO VARIOUS SCHOOL BUILDINGS AND GROUNDS ON BEHALF OF THE ORANGE BOARD OF EDUCATION PUBLIC SCHOOL DISTRICT BY THE CITY OF ORANGE TOWNSHIP, IN THE COUNTY OF ESSEX, NEW JERSEY, APPROPRIATING \$2,506,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$2,506,000 BONDS OR NOTES OF THE CITY TO FINANCE THE COST THEREOF</b>

<b>Purpose(s)</b>	The purpose of the bond ordinance is to authorize the appropriation of \$2,506,000 and the authorization of bond and/or temporary notes in the amount not to exceed \$2,506,000 to finance various Improvements to various school buildings and grounds including, but not limited to, Scholar's Academy, Oakwood Avenue Elementary School, Heywood Avenue Elementary School, Rosa Parks Community School, Forest Street Elementary School, Orange Preparatory Academy, Lincoln Avenue Elementary School, Orange High School, Orange Early Childhood Center, Park Avenue Elementary School, Career and Innovation Academy, IT Administration Building, and the Board of Education Administration Building.
