**Library:** Councilman Jackson reported that he had met with Library Director Davis and they

discussed items that had been and are currently being repaired. Mr. Garzon, a representative of the library union, reported that there were no communications between the Library Board and the union. He had tried to communicate with the Board for months regarding the employees pay raises and they have not responded nor have the employees received their raises. Mr. Garzon reported on a number of concerns regarding library employee's pension payments and loan payments along with issue of wall repairs. After further discussion Council President Coley would like an investigative committee to look into this matter by the City Law Department. Councilwoman Williams stated that it was not incumbent for only the tax payers to submit funds to the Library. The Library had not done any fund raisers or applied for grants. The Council had discussed fund raising and grants with the

Library last year.

**DPW:** Ms. Gordon stated that the committee would like the Council President to attend

the next meeting and in the future to have the City Planner come and review the

City Master Plan, environmental issues and the water drainage issues.

**Housing:** Councilman Johnson, Jr. will have a report at the next meeting.

**Fire:** Captain Vitiello provided a report on the arrest within the city, street level

operations, walk through in schools and an orientation for candidates that will start the academy in January. There are 13 candidates that will be graduating this December and there will be 20 starting this January. Violent Crime has gone down 27% in the last 8 months. Captain Vitiello answered questions and took suggestions

from the Council Members.

**Police:** Chief Spearman reported they have been enhancing their relationships with the

surrounding towns and conducting more training for their Captains regarding fire inspections. The Fire Department is part of the D-con task force. Chief Spearman

reported on seminars that the fireman will be attending. He spoke about what the Fire Department was doing for Fire Prevention Month. Chief Spearman answered questions by the Governing Body.

## CITIZEN COMMENTS ON GENERAL ISSUES/AGENDA ITEMS

The City Clerk made the following statement:

Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to Five (5) minutes.

The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments.

The following residents and business owners made comments.

- Mr. Jeffery Feld spoke about the list of questions that he had sent to the Council and the City Administration. He spoke about the law suits that he and his family have made toward the city and some of the results of those cases. Mr. Feld had issues with the way the city handled those cases. He spoke about the lack of current information and the miss information that is on the city website.
- Ms. Mary Bonds commented that she has been a library employee for the last 40 years. The employee morale is very low. She spoke about the computers being down, the bathrooms being stuffed up, flooding in the library from rain. The Library Board does not respond to the employees. Ms. Bonds reported that she had called the State and that Mr. Davis, Director of the Library, is now officially a civil servant. Mr. Davis was not certified so therefore he was under the direction of the Library Board. Now that he was not under the Library Board's authority, she asked for the Council to work with Mr. Davis so things could be done. Ms. Bonds continued to review the issues that concern the library. She stated that the money for the library is not being monitored. Employees come and go and they are not civil servants.
- Ms. Gloria Stewart commented that she was overwhelmed by the news that she had heard
  that evening. She was dismayed the Mayor was not present. She requested information by
  the State regarding an employee being a finance Director in one town and a Mayor in
  another. She was concerned about the library issues. With regard to Resolution 328-2017
  she would like to see that resolution approved.
- Ms. Karen Wells spoke about a report regarding transparency that will be completed for the residents. It will be detailed information regarding the work of city officials. A grade will be given . The information will be factual not one sided.
- Ms. Katelyn Gordon spoke about the citizens comments and how the current setup for response to those questions do not allow residents to correct people when they misunderstood the original question. She would like a change to the procedure. She would like the Council to respond to comments as well as questions. She also commented

that she has not been able to reach the Council 24/7 as promised by the Council Members and provided suggestions on better ways for the Council Members to be available to the residents. Ms. Gordon had requested a copy of the 2015 bulk tax lien sale contract by way of an OPRA request. She spoke about other issues she wanted answers to.

Mr. Tyrone Tarver, spoke about the Board of Education going to court to take off the
question of elected members to the Board of Education on the November ballot. He
spoke about the fake news and information that was being circulated around the city
regarding the referendum.

Motion to close Citizen Comments by Councilwoman Wooten, seconded by Councilwoman Summers-Johnson.

The Motion was approved by unanimous vote.

## Some responses to resident's questions and comments.

Business Administrator Hartwyk answered the general questions regarding the administration and the website.

Attorney Pennington answered questions regarding the filings of the Board Of Education. Business Administrator Hartwyk commented that there was an error in Resolution 309-2017 regarding the Tax Assessor's position.

Council President Coley stated that the Housing Authority will present their annual plan to the Council. He stated that there is a new procedure for questions from the residents and provided the procedure for the residents. Council Members can speak on comments by residents but they have no obligation to do so.

Business Administrator Hartwyk reported that he turned over all documents that his office had on the 2015 bulk tax lien sale but there was no contract. He commented that there was the bid documents, the winning response together with the checks and the City Council resolution. Those documents were turned over to Ms. Gordon.

#### **COUNCIL COMMENTS**

- Councilwoman Summers-Johnson commented on voting in Orange and how
  Council Members would not sway anyone to vote for or against something or
  someone. She thanked the Mayor and the Business Administrator for providing a
  bus for the historical tour. She spoke about the red line and that any realtor that
  refuses to show a house in a certain section of town could lose their license. She
  also spoke about how much better the store fronts look.
- Councilwoman Eason reminded residents of Pink out for Cancer on October 14<sup>th</sup>.
   She commented that new stores on Main St. have been putting their merchandise out in front of their stores. The Business Administrator stated that the city is working on that. She stated that she does not agree with an elected school board at this time. She wants the streets to be cleaner.
- Councilman Jackson commented that the Council does not have authority over the Library Board. Many of the things that come to us about the library are not legislative functions and we have to be clear on what things can and cannot be changed by the Council. Many of the complaints about the library are controlled by the administration.
- Councilman Johnson commented that the library is a mess. He did not feel that the Council should add money to the library budget and not have a say in what is

going on in it. He has not seen anything getting better there. Employees come and go which takes money out of their budget. They will not do fund raisers. Councilman Johnson spoke about the 2015 Bulk tax lien sale was not finalized by the winner the rights were given to a 3<sup>rd</sup> party. He stated that he could not get any documentation on the sale to the 3<sup>rd</sup> party.

- Councilwoman Williams stated that she has asked for the same documentation.
  She asked the Clerk's Office to prepare a weekly calendar for the Council as to
  what is going on in the following week. She it would it sent to Council Members
  every Friday. She asked that there be a closed session for a Law Department
  report on all open cases and a safety report from the Police Department. She spoke
  about the Orange Home Coming Week.
- Councilwoman Wooten spoke about the state of the Country and the state of the City. The city is a work in progress and resident should come to the community meetings and provide suggestions that the Council can work on. She compared the bad things that are going in the country to what is going on in Orange. She felt that Orange was doing a lot better than most. There are bad things in the city and really good things in the city. Think about the people shot in Las Vegas and the floods in Texas and other countries and then think about this city's concerns. She spoke about some suggestions that she will bring up to the Mayor and the Business Administrator.
- Council President Coley asked for and received an update on the wells from the Business Administrator. Well 2 was fixed and well 5 was still broken. Well 6 went down. The wells are old and there will be a Capital Appropriation Ordinance authorizing some improvements to the wells. American Water and East Orange Water are the only two entities that can provide a direct bulk water purchase connection. He spoke about the pricing differences and stated that there would be a meeting. He also reported that someone from the administration will be attending the Mayor's Conference in Summerset, NJ.
