Inspection of said items will take place the day of the auction between the hours of 10:00 a.m. and 11:00 a.m. at Brook Alley Garage. All items will be sold on an “AS IS” basis, without any warranty or guarantee whatsoever. **ALL SALES WILL BE FINAL.**

At the discretion of the City, all successful bidders must have a valid driver’s license and a working phone number. **NO** titles or ownership papers will be released until vehicles are removed from Brook Alley Garage by successful bidder. These documents shall be provided at the time of removal.

Successful bidders have 48 hours from day of sale to remove vehicles from City property. Any successful bidder failing to remove vehicles from City property within 48 hour time frame, will be issued a summons for Abandoned of Motor Vehicles, N.J.S.A. 39:4-56.5.

Full payment is required in cash, business/company check, certified check, bank check or money order at the completion of the bidding process. No personal checks shall be accepted.

The City of Orange Township reserves the right to accept or reject any bid or bidder if in its judgment the acceptance or rejection is in the best interest of the City of Orange Township.
