An application for zoning permit approval and/or zoning information shall be deemed administratively complete upon submission of all of the following items to the zoning official/officer:						
	1 completed original of the Application, including any additional explanations.					
	1 complete set of surveys, schematic and/or architectural drawings (i.e., floor plans).					
	1 Statement of ownership (if applicant is the property owner), or copy of a lease or other evidence of applicant's relationship with the property's owner					
	1 completed original IRS Form W-9, Request for Taxpayer Identification (business entity applicants only).					
	1 Business Registration Certificate (business entity applicants only).					
	1 copy of business formation document or sole-proprietorship long form (business entity applicants only).					
	Certified check equal to \$100.00, payable to "City of Orange Township".
