

## NOTICE TO BIDDERS

Notice is hereby given that sealed proposals will be received by the **City of Orange Township**, Essex County, New Jersey for **Stirling Avenue and Residential Area Road Improvements** and opened and read in public at the City of Orange Township City Hall, 29 North Day Street, 3<sup>rd</sup> Floor Council Chambers, Orange, New Jersey 07050, on **Wednesday, February 24, 2010 at 10:00** am prevailing time.

Contract Documents for the proposed work may be examined Monday through Friday, except legal holidays, from 9:00 am to 4:00pm, at the office of Public Works and Engineering (Room #204), 29 North Day Street, Orange, New Jersey.

Contract documents, prepared by Dennis J. Mantlick, P.E., may be obtained from T & M Associates, Consulting and Municipal Engineers, 1373 Broad Street, Clifton, New Jersey 07013, during the hours of 9:00am to 4:00pm, Monday through Friday upon payment of a non-refundable fee of One Hundred Dollars (\$100.00) by cash, check or money order payable to T & M Associates to defray the cost thereof. **PAYMENT MUST BE RECEIVED PRIOR TO OBTAINING SAID PLANS AND SPECIFICATIONS, EITHER BY MAIL OR IN PERSON.**

Proposals must be made on the Standard Proposal Forms in a manner designated in the contract documents, must be enclosed in a sealed envelope bearing the name and address of the bidder and the name of the work on the outside, addressed to the **City of Orange Township** and must be accompanied by all items identified in the Contract Documents including, but not limited to, a Statement of Consent of Surety from a surety company holding a Certificate of Authorization to do business in the State of New Jersey and a bid guarantee (Proposal Security) for not less than ten percent (10%) of the amount bid except that the guarantee need not exceed \$20,000.00.\*\*

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27.

Bidders are also required to comply with other provisions of Law including, but not limited to, the requirements of:

- N.J.S.A. 52:25-24.2 (P.L. 1977, c.33, Disclosure of Ownership)
- N.J.S.A. 52:32-44 (P.L. 2004, c. 57, Business Registration)
- N.J.S.A. 34.11-56.25, et seq. (P.L. 1963, c. 150, Prevailing Wages)
- N.J.S.A. 34.11-56.48 (Public Works Contractor Registration)

The contract shall not be approved until a favorable eligibility determination has been made by the New Jersey Department of Transportation.
